### ORDER

As per the Government Order read as 1<sup>st</sup> paper above, Government have accorded sanction for the revision of scale of pay of 7 permanent employees of Kerala Bureau of Industrial Promotion (K-Bip) w.e.f 01.04.2011. This revision of pay was sanctioned by adopting revised pay scales as per Government Orders read as 2<sup>nd</sup> and 3<sup>rd</sup> papers above. As per the Government Order read as 1<sup>st</sup> paper above, the then existed scale of pay of Shri. V. Rajagopal, Chief Executive Officer, Kerala Bureau of Industrial Promotion (K-Bip) i.e. 25400-33100 was revised to 42640-58640. Since the revised scale of pay of 25400-33100 in the pre revised scale of pay is 44640-58640 as per the present pay revision order mentioned above, Shri.V. Rajagopal, Chief Executive Officer, Kerala Bureau of Industrial Promotion (K-Bip), as per the letter read above, has requested to rectify the anomaly and grant him the scale of pay 44640-58640.

Rajagopal, Chief Executive Officer, Kerala Bureau of Industrial Promotion (K-Bip) in accordance with pay revision order 2011 so as to rectify the anomaly occurred in revising his scale of pay as per pay revision order 2011 subject to the condition that this scale of pay as Chief Executive Officer will be purely personal and applicable to Shri. V. Rajagopal as long as he continues in the post of Chief Executive Officer, Kerala Bureau of Industrial Promotion (K-Bip) [ie as his personal scale].
